## About the Artist Grant

The Artist Grant is designed to help emerging artists from underrepresented groups whose practices involve some form of collaborative, collective, or creative processes that incorporate or benefit their community.

This grant program is informed by extensive research into the challenges emerging artists in Europe and beyond are facing, as well as by learnings from previous open calls and hundreds of applications to our grant programs since 2022.

Our aim—through this grant—is to improve living conditions for artists, enable them to dedicate more time to developing their practices, to increase the visibility of their work, and to boost their self-confidence. Ultimately, this grant program aims to help emerging artists realize their creative potential.

## About The Supporting Act Foundation

The Supporting Act Foundation (TSAF) is an independent nonprofit organization with a mission to enable emerging artists dedicated to fulfilling their creative potential, prioritizing those from underrepresented or marginalized groups. We

aim to support ambitious nonprofit organizations, helping them build more equitable art scenes and creating opportunities for growth and expansion in their work.

## What are we offering?

We are offering 10 unrestricted grants of €10,000. These will be transferred in monthly installments of €1,000 over a period of 10 months (January–October, 2027). There are no restrictions on how you choose to spend your grant, though it is intended to help cover living costs and expenses associated with your artistic development, including but not limited to the securing of workspaces, purchase of equipment, paid courses, or anything that helps you progress.

We also provide non-financial support. Our Grantee Network offers online events where grantees can share their work, challenges, and experiences with peers. Whenever possible, we also showcase and promote grantees' works across our various communications channels.

## Who is this grant for?

### Eligibility criteria

Before preparing your application, please read the following pages in full and ensure that you meet all eligibility criteria.

To be eligible for this open call you must:

1. Identify as an emerging artist and have at least two and no more than 10 years of professional experience.<sup>1</sup>
2. Be developing an artistic practice that involves some form of collaborative, collective, or creative processes that incorporates, or benefits, your community.

<sup>1</sup> We define professional experience as actively engaging in an artistic practice across one or more disciplines and treating this work as the focal point of your career, while being recognised by peers or the arts community for your commitment and contribution, regardless of income or employment status.

3. Identify as belonging to an underrepresented group<sup>2</sup>, or as someone who consistently faces systemic barriers to equal opportunities in career development, exposure, or access compared to the majority of artists in the creative and cultural industries in your country.
4. Be based in either Belgium, France, Germany, Greece, Ireland, Italy, Netherlands, Portugal, Spain or the United Kingdom and have a personal bank account with IBAN number under your name in one of these countries.
5. Be born in or before 2005.
6. Have an updated website or public social media profile where your artistic works are publicly shared.
7. Clearly outline how you intend to use the grant, and explain the specific ways it will support your artistic development.
8. Be able to demonstrate how the grant will support you in overcoming economic, social, cultural, physical and health-related barriers that would otherwise prevent you from progressing your career.
9. Be willing to demonstrate enthusiasm and commitment to being a positive ambassador for the growing TSAF Grantee Network.

This open call is not for: Former or current TSAF grantees.

## How to apply?

Once you have read this guide and checked whether you are eligible, please follow the below steps to submit your application:

1. Go to [thesupportingact.org/programs](https://thesupportingact.org/programs) and select “2026 Artist Grant”.
2. Click “Apply” to access our open call platform powered by Good Grants.
3. Create an account with a valid email and verify it as instructed.
4. Enter your name, create a password, accept the platform’s terms, and complete registration.
5. Click “Start Application”, under “2026 Artist Grant”.
6. Fill out the eligibility form. Only eligible applicants will be able to proceed.
7. Complete the application form. (Preview all questions and fields in Annex 1 of this document). You can save and return anytime during the open call.
8. Once your application is ready, click “Submit”.

### **Deadline**

The deadline for applications is **October 1, 2026** (11.00 AM CET).

Please allow ample time for uploading your applications, especially if they include large files such as videos.

We can only accept applications in English, but please note that all applications will be read with an understanding that English might not be the first language of the applicant.

### **Notifications for applicants**

After submitting an application, you will receive a confirmation email and future notifications from [no-reply@app.goodgrants.com](mailto:no-reply@app.goodgrants.com) and [sender@app.goodgrants.com](mailto:sender@app.goodgrants.com). Please make sure to add these emails to your contact list to avoid them going to your spam folder.

If you're pre-selected for a grant, you will have one week to reply to our notification. In case we don't hear from you, the grant will be reassigned to another applicant. Unfortunately, due to limited capacity, we will not be able to provide individual feedback.

## **Selection process**

### **2026 Artist Grant Selection Committee**

The funding decision will be made by an independent committee of five artists, curators, and editors, each with lived experience as emerging artists themselves, or having worked with them, including TSAF grantees from previous years.

The selection process for the 2026 Artist Grant has three rounds:

### **Round 1: Eligibility & Ranking**

While we welcome as many eligible applications as possible during the open call period, please note that the Selection Committee will be able to review and score up to 100 applications only.

If we receive over 100 eligible applications, we will rank them based on the information provided in the survey section of the application form. In line with our mission, we will prioritise applications from artists with less access to financial resources and those who might face greater systemic discrimination.

### **Round 2: Review & Scoring**

The Selection Committee will review up to 100 eligible applications. Each application will be scored by two members, creating a ranked shortlist of 20 applications that will advance to the final round.

**If you are shortlisted**, you will be notified by email on 21 October and required to submit proof of identity, eligibility, and bank details by 27 October 2026. This means we will request a copy of your ID, and proof you have an active bank account in one of the eligible countries, for example by providing an utility bill, or bank statement.

! Please note that failure to respond to our email and submit the requested information within the stated deadline will result in your application being withdrawn from the process.

If you are not shortlisted, we will also notify you during this week.

### **Round 3: Final Selection**

The 20 shortlisted applications – contingent on successful submission of due diligence – will be evaluated by all seven members of the committee. They will then meet to reach a consensus on the 10 applications to be awarded the grants.

### **Final steps**

If you are pre-selected for a grant, you will be notified by email before 21 November. The email will include an invite to schedule a brief introductory video call. Please note the following required steps:

- Book your introductory video call with the TSAF team (so we can get to know you a bit better and introduce ourselves!) by Friday 27 November.
  - Calls can be scheduled for any slot between November 23 and December 3, 2026.
  - ! Failure to respond to the email or complete the call within this window will result in your application being withdrawn and an alternative applicant being considered.
- The Donation Agreement will be shared with you for review and signature during the same week.
- You will also be asked to submit any assets that can best support our communications.
- Once the agreement is signed, the first of 10 monthly installments will be scheduled for January 2027

## Timeline

- Applications review (Rounds 1 & 2): October 2026
- Notifications to all applicants & due diligence request to shortlisted: late October 2026
- Due diligence submission deadline: end of October 2026
- Final review (Round 3): November 2026
- Intro calls with pre-selected grantees: November 23 – December 3, 2026
- Sign agreement and submit assets: December 2026
- Public announcement and transfer of first installment: January 2027

## Review criteria

Applications that pass the first round of the application process, outlined above, will be reviewed and scored using the following criteria:

- ❖ The degree of alignment between your artistic practice and the focus of the Artist Grant program.
- ❖ The level of community engagement in your artistic practice.
- ❖ The level of clarity you show as to the potential impact that the grant may have on your artistic development and career.
- ❖ The level of commitment and dedication to your artistic practice.
- ❖ The level of creative potential displayed in your work, trajectory, and plans.
